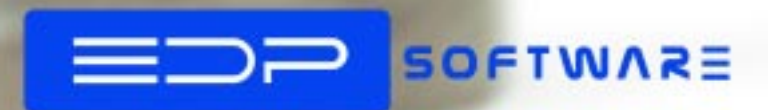

Criminal Justice Paradigm

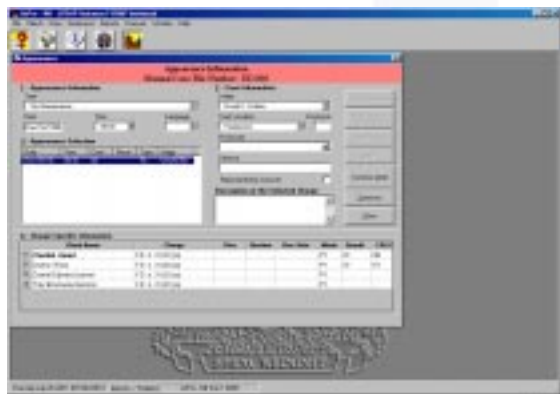

In the ever-present goal of improving the quality of service, legal institutions are relying on technology to provide the solutions.



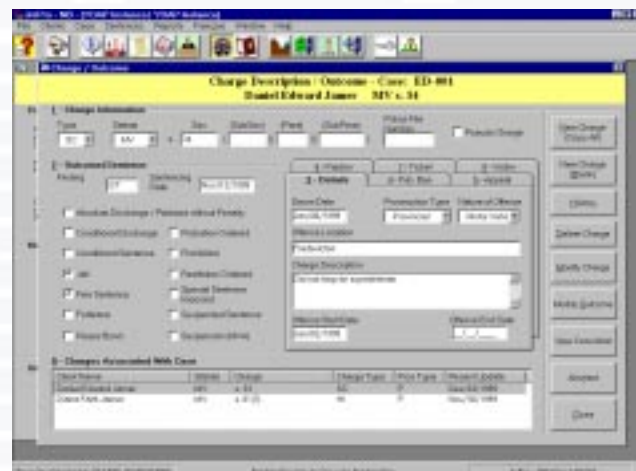
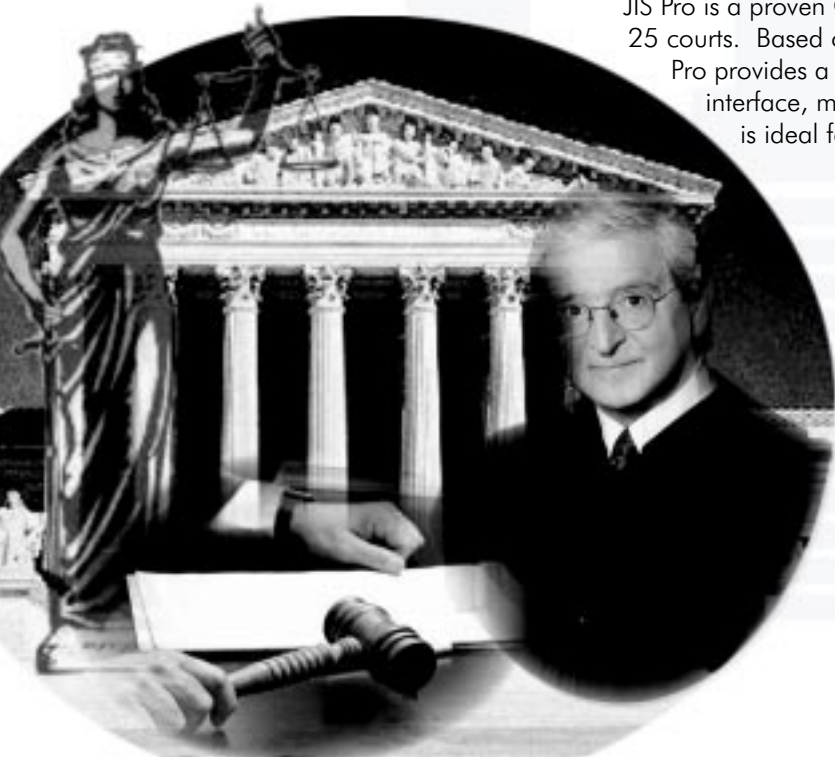
